Submitting a film to FoFVA constitutes an agreement by and between the filmmaker and FoFVA. By submitting the filmmaker(s) agree to all of these terms and conditions.

Submission Agreement: As the filmmaker I am duly authorized to submit the film titled:

to the LOL Friends of Film Funny Film Fest sponsored by Friends of Film, Video and Arts (FoFVA) – AND the Nickel Independent Film Festival. I hold both festivals harmless from damages to or loss of the film print en route due to improper containers of otherwise. The film is not subject to nor is threatened by litigation and that I accept all of the submission regulations stated within the agreement form. I also know that further agreements may be necessary.

Submission Guidelines: Selected works need to be submitted on two DVDs for reviewing purposes. Submission(s) must be a self-contained QuickTime Movie File or AVI file, or a format that can be added to a Final Cut Timeline. These are 'data' files burned to a DVD, and you may submit multiple entries. DVDs must be labeled with Your Name AND Name of film. **Test your DVD on a consumer player before sending.** Send: (1)DVD's (2)Completed/signed Entry Form (3)Completed/signed Submission and Exhibition Agreement (4)Entry fee(s) - check or Money Order only

Rights & Clearances: Filmmaker assures they have secured all rights, licenses, clearances and releases needed for exhibition. By submitting this material you acknowledge FoFVA's right to copy any submitted material for FoFVA and Fest's non-commercial use only.

Shipping: You are responsible for the arrangements and cost of delivering the exhibition copy to FoFVA. The copy will not be returned. **Final deadline for receiving submissions is February 25th, 2012 5PM.**

Publicity: Upon request you will supply FoFVA with stills and other press materials. You should be available for interviews prior to and during the LOL Fest.

Loss & Damage: Every precaution will be taken to safeguard DVD's and publicity materials while they are in the possession of FoFVA. However if loss or damage occurs FoFVA cannot accept or assume responsibility.

Personal Release: I, the filmmaker allow FoFVA and any third parties assigned by FoFVA, the right to film, videotape and photograph my appearance and voice for any and all marketing and promotion of the festival.
